We are designed and built for a bright future.



FINANCIALS



SKILLED TRADES EMPLOYMENT PROGRAM



STEP has been supplying BC construction employers with job-ready workers for skilled trades and general labour jobs since 2006. From screening and assessment to training and supplies, STEP quickly finds and prepares the right candidates for your skilled trades jobs and apprenticeships.

STEP serves employers across BC with RCA-based offices in Prince George, Kelowna, Vancouver, Nanaimo and Victoria and additional locations in Terrace, Prince Rupert, Fort St. John, Kamloops, Nelson, and Abbotsford.

Job placements are achieved by ensuring our Regional Employment Placement Specialists continue to build and maintain relationships with employers, other employment service providers, schools/training providers, and community organizations with specific participant target groups such as women, immigrants, aboriginals, and youth. STEP is Canada's only demand-side employment program.

BidCentral is BC's largest online construction bidding marketplace, providing a single entry point for all ICI (Industrial, Commercial, and Institutional) construction projects in BC. Public, private, by-invitation only, and Prebid opportunities are all easily accessible from our main dashboard:

- Trade contractors, suppliers and manufacturers use BidCentral to source bidding opportunities.
- General contractors and construction managers also use BidCentral to post and manage private, invitation only projects.
- Bid authorities use BidCentral to publish and procure suppliers for major public construction projects.
- The BidCentral platform serves the industry at large, allowing all contractors to access project information and documents through the expansion of Premium and Enterprise access levels.

The new BidCentral Prebid (early project) information area of the platform was added this year and is available exclusively to Premium account holders.

The Council of Construction Associations (COCA) was created to present a united front and a systematic approach to WorkSafeBC issues. COCA represents 20 construction associations from all regions of BC and every sector and size of company, both union and non-union. The BCCA contributes operational funding and has three Directors that sit on COCA's Board of Directors.

COCA has positive financial impact on our contractors' WorkSafeBC costs: The average assessment rate for the Construction Industry is less than half of what it was 20 years ago (from \$5.83 per \$100 of payroll to \$2.74).

COCA's advocacy on behalf of member organizations ensures that regulatory changes are reasonable and effectively promote worker safety.

In 2016-17, COCA advocated for industry on issues including: permanent disability evaluation, joint OH&S committees, measurement of earnings, COR, asbestos, and silica.


