# A NOTE FROM THE BOARD

It is my privilege to present the BCCA Annual Report for the fiscal period April 1, 2017 - March 31, 2018, on behalf of the BCCA Board of Directors.

I began my position as BCCA Board Chair in September 2017, taking the helm from Bob Cooke, CEO of Division 15 Mechanical. Bob, working collaboratively with representatives from the four Regional Construction Associations, had guided our network of organizations through several senior leadership changes and built a new blueprint for collaboration.

From this solid position my tenure as BCCA Board Chair began, with two events defining the year:

1) NDP MLA John Horgan was sworn in as the Premier of British Columbia on July 18, 2017 and BC found itself governed by a coalition. The Green and NDP parties were in charge, holding 44 seats to the Liberal's minority 43 seats.

2) The BCCA Board approved a new three year strategic plan focusing on four key pillars:

- Construction Projects
- Skilled Workforce
- Technology
- Community

I commend the BCCA Board for the quality of the Strategic Plan, which has been an excellent guide for the organization through some swiftly moving political currents and new opportunities.

In this climate it's worth reminding ourselves that BCCA is a unique organization in BC's construction sector, founded as it is on non-partisan principles and a spirit of collaboration and optimism. This sets us powerfully apart from other provincial construction organizations, allowing us to represent all employers in a fair and balanced way. At no time in recent memory has this been more significant a differentiator for us, and we have worked to respectfully move government forward on key issues such as prompt payment, small business taxes, community benefit agreements, major projects such as Site C and the Kinder Morgan TransCanada Pipeline, skilled workforce training, and improving public sector procurement expertise.

To say that it's been an immensely busy time is an understatement considering the many provincial initiatives under the leadership of the BCCA. For example: the introduction of BC's first "Construction Month", planning the Understanding Risk Symposium, the Infrastructure Masterclass, the Deputy Minister's Industry Infrastructure Forum, LNG Canada Trades Training Fund and Connect Program, IN, and STEP, the expansion of BidCentral, and

the initiation of the Construction Workforce Equity Project, a new program to improve retention rates of tradeswomen in our industry.

My sincere thanks go to the regional Board Chairs for their ongoing commitment to our shared success, and I confidently pass the torch to the incoming Chair Angela McKerlich from SICA. Angela has done phenomenal work with the Governance committee during the past year, and I know under her guidance BCCA will continue to ensure that our province is home to a world-class construction sector that demonstrates exceptional productivity and resilience.

# PRESIDENT'S MESSAGE

We have plotted a new course for BCCA and I am proud to be at the helm as we continue our voyage through familiar waters as well as across uncharted depths. OK - I'll ease off on the nautical metaphors from this point forward but I did want to pay homage to the theme of this year's Annual General Report and BCCA's two seafaring Board Chairs during this term, Alan Fletcher and Bob Cooke. Both have been instrumental in ushering in a new three-year strategic plan, providing the required leadership and trust that allowed us to deliver on our stated objectives with the flexibility to pursue emerging industry issues as necessary. The new BCCA strategic plan (2017-2020) was approved at our September AGM in Kelowna after the foundation was laid in June at our facilitated session in Vancouver.

I have appreciated the many opportunities to engage with our partner RCA's at their hallmark events such as the CCVI Conference in Nanaimo, the Construction Leaders Forum in Whistler, the Natural Resources Forum in PG and the Contractors, Consultants and Owner (CCO) event in Kelowna. Any opportunity to be in the regions and working with the CSO's and their teams is a valuable and insightful time for me, enabling my representation of our collective interests at the Provincial and National level.

This year BC elected a minority NDP Government which has become a coalition government with the Green Party by way of a Confidence and Supply Agreement. BCCA has been able to engage consistently, collaboratively and successfully with both parties while maintaining a favourable reputation

with the opposition Liberal Party. Our non-partisan approach and our willingness to bring forward proactive recommendations have opened doors for meaningful dialogue.

BCCA has introduced key capital spending ministries to the Infrastructure Masterclass program in order to assist in the development of waning public sector procurement capacity. This focus serves our integrated membership, the industry as a whole, the government of the day and BC taxpayers. In addition we have supported this new curriculum with a public sector project report card that informs our Best of Procurement Awards, which were introduced during this year to significant appreciation and impact.

BCCA has advanced a fresh concept and new initiative for our industry: the opportunity for the construction industry to act as an "essential responder" in catastrophic natural risk such as including wildfire, flood, seismic and tsunami occurrences. In discussions with Emergency Management BC they see a valuable role for construction as part of the preparation, response and recovery process and are keen to bring our sector to the table. This discussion has also garnered national attention.

BCCA was busy throughout the first quarter of 2018 as BC Construction Month prepared to launch with an official proclamation, and a series of announcements and events to raise the positive profile of our sector. Planned announcements include our Hard Hats and Hockey Sticks initiative with BC Hockey and our continued involvement with the BC Lions and the Salute the Trades Night.

These and other efforts will help us synthesize our value across government as we pursue the best interests of the industry as it relates to existing and emerging topics, including:

- The BCBid replacement project (positioning of BidCentral) – *Ministry of Citizen Services*
- Prompt Payment legislation – *Attorney General*
- Prompt Payment solutions in technology – *Ministry of Jobs, Trade and Technology*
- Construction Workforce Equity Project – *Ministry of Advanced Education Skills and Training*
- Community Benefits Agreement – *Ministry of Transportation and Infrastructure*

Finally, I must acknowledge the tremendous staff at BCCA. The work they do is professional, value-laden and often thankless but they are passionate and dedicated to the association they serve. I am so proud to have a team that finds meaning and value for their efforts and I sincerely appreciate their significant contributions to BCCA.

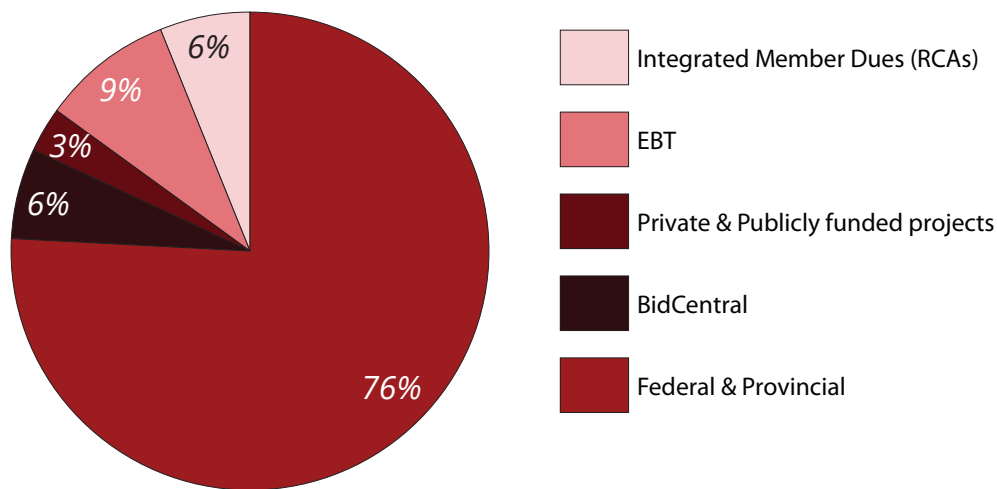

# FINANCIALS

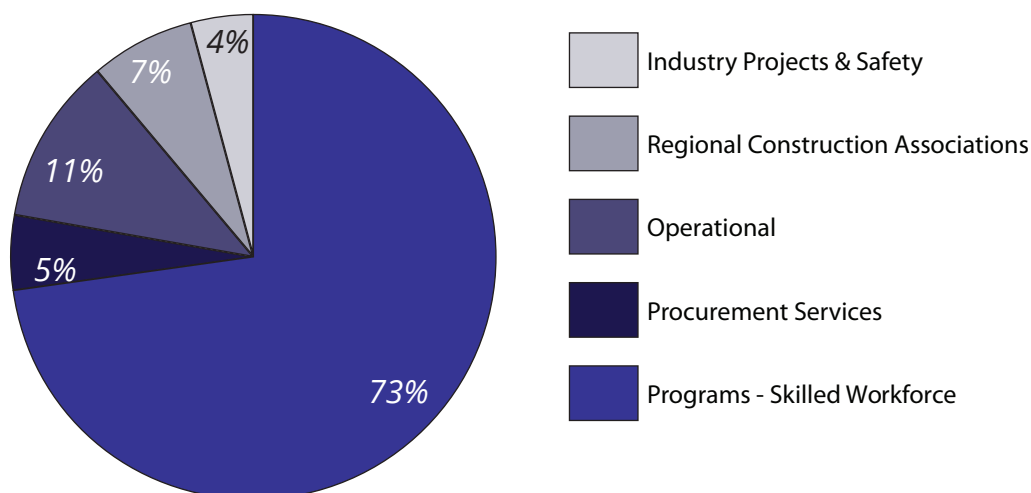

# PROGRAMS & SERVICES

SKILLED TRADES EMPLOYMENT PROGRAM



The Skilled Trades Employment Program (STEP) has been supplying BC construction employers with job-ready workers for skilled trades and general labour jobs since 2006. From screening and assessment to training and supplies, STEP quickly finds and prepares the right candidates for your skilled trades jobs and apprenticeships.

STEP serves employers across BC with RCA-based offices in Prince George, Kelowna, Vancouver, Nanaimo and Victoria and additional locations in Terrace, Prince Rupert, Fort St. John, Kamloops, Nelson, and Abbotsford.

The program's success is due in large part to STEP's Regional Employment Placement Specialists (REPS) who work and live in the communities they serve. REPS continue to build and maintain relationships with employers, other employment service providers, schools/training providers, and community organizations with specific participant target groups such as women, immigrants, indigenous peoples, and youth. REPS regularly attend events such as job fairs and career days and consistently deliver presentations in high schools and foundation courses to increase awareness.

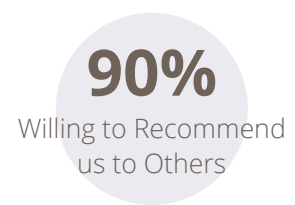
As the Plan Administrators, the BCCA EBT is committed to working with all our employer groups in managing the employee benefit plan

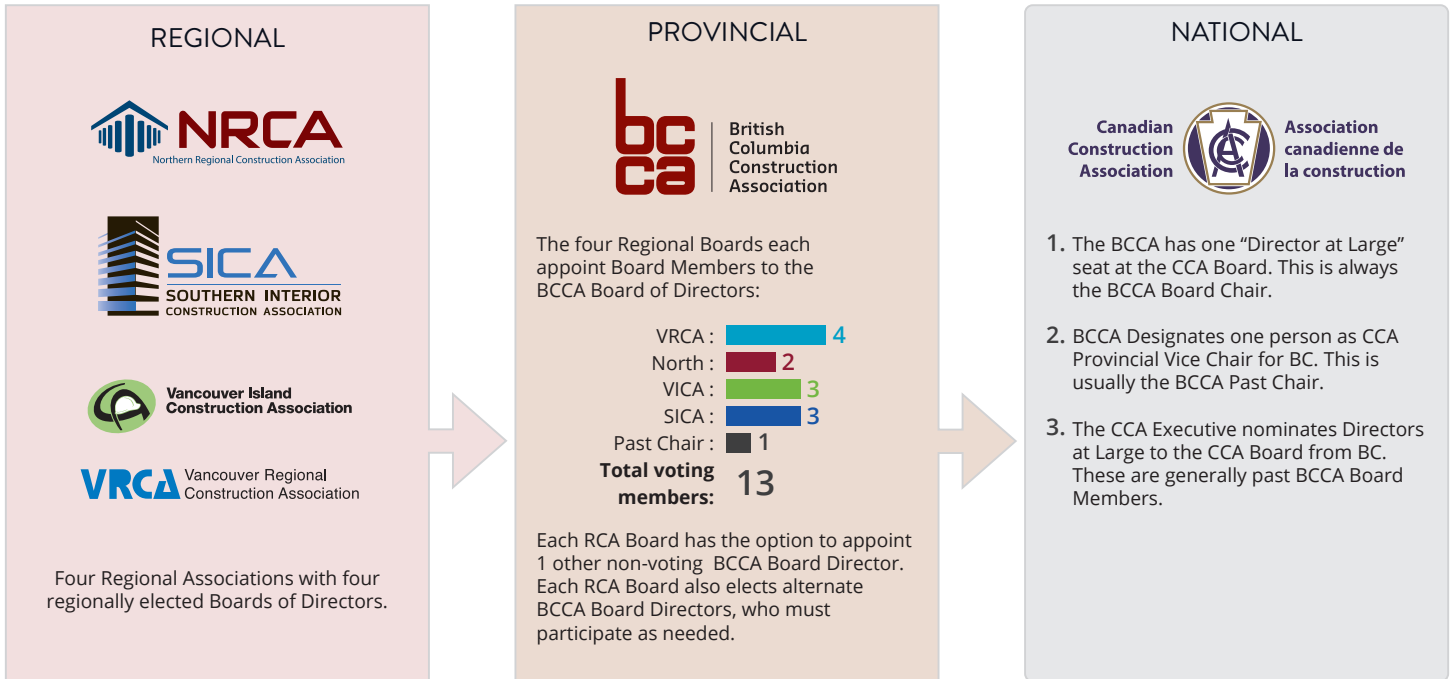

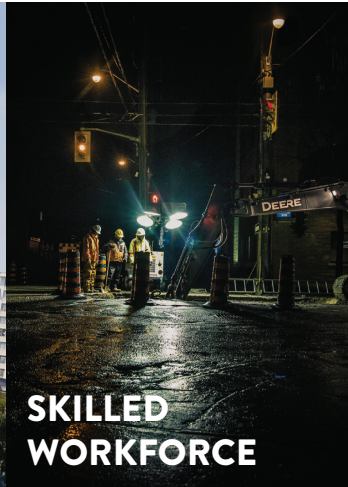

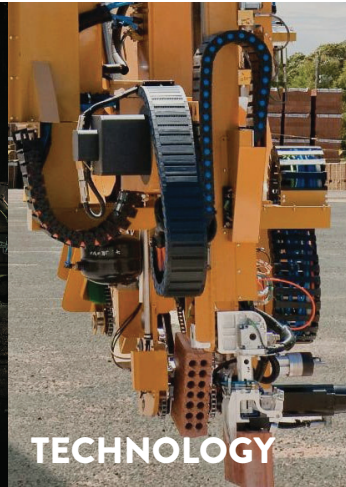
