TALENT RETENTION

BCCA Employee Benefit Trust (EBT) – Providing exceptional health benefits to construction industry employers for 50 years.

BCCA Employee Retirement Savings Plan (**ERSP**) – Providing employee retirement security to the construction workforce.

BCCA Retiree Plan (RP) – A customized health plan for retiring employees.

LNG Canada Trades Training Fund (TTF) – Providing funds for apprenticeship training in in-demand trades.

Construction is a complex business. Safety is mandatory. Access to timely, high quality project information is essential. Getting paid on time is crucial. BCCA will continue to lead industry in the pursuit of site safety, public sector procurement best practises, quick and easy access to all the latest project information (through BidCentral, BC's largest construction bidding marketplace), and prompt payment legislation.

INITIATIVES

BidCentral Online Bidding for

Subcontractors (BOBS) – Digital procurement platform that maintains a fair and equitable process for trade contractors and helps general contractors close a tender with less stress. Owners benefit from fair and transparent processes.

Deputy Ministers & Industry

Infrastructure Forum (DMIIF) – The BCCA co-founded this government and industry roundtable, chaired by the Deputy Minister of Finance and a BCCA Board Member, to aid in collaboration between government and industry on public policy, legislation, regulation, programming, and other actions that impact industry.

Standard Practices Committee – BCCA leads and manages this team of industry experts behind standard documents, keeping an eye on the quality of public tenders.

Council of Construction Associations – A committee of BCCA, presenting a united and systematic approach to the health and safety efforts of WorkSafeBC, Technical Safety BC and the Provincial Government.
