PROMPT PAYMENT LEGISLATION: IT JUST MAKES SENSE


PAYMENT CERTAINTY IS ESSENTIAL

Prompt Payment Legislation will ensure BC's builders are paid on time, and that the construction projects BC desperately needs move ahead in the most efficient, fair and effective way possible. It will allow critical housing and infrastructure projects to proceed with confidence and will create certainty and efficiencies strengthening industry competitiveness and productivity.

The lack of payment certainty which plagues this province's construction industry disproportionately affects the contractors, subcontractors and tradespeople who build BC. Payment delays lead to cash flow problems and exacerbate the inequalities of bargaining power in contracts, putting businesses in jeopardy and threatening livelihoods throughout the construction pyramid.

Prompt Payment Legislation is already in place in most Canadian jurisdictions. British Columbia's failure to immediately enact this legislation weakens its ability to compete nationally and retain the investment and workforce it desperately needs to build and maintain our province. 88% of the construction industry is reporting late payments on invoices. This avoidable strain and ever-present economic risk is unconscionable.


Economic Stability

THE BUSINESS CASE FOR THE ADOPTION OF PROMPT PAYMENT LEGISLATION IS STRONG:



Ensures the construction industry remains capable of delivering the housing and infrastructure essential for British Columbians.



Provides recourse and enforcement mechanisms to address payment delays which have become normalized in BC.



Facilitates cash-flow down the construction pyramid which is highly susceptible to payment "freeze-ups".



Alleviates the disproportionate burden of payment delay borne by parties near the base of the construction pyramid.



Mitigates the impact of paid when paid, paid if paid clauses and addresses inequalities of bargaining power among parties while preserving their freedom of contract.

Provides consistency with respect to applicable timelines, payment obligations, and enforcement mechanisms across all sectors of the construction industry.

Certainty for industry = payment certainty + clear resolution timelines
